Affidavit

VIOLATION OF COMMUNITY CORRECTIONS

Before me, Honorable Larry B. Stanley, Jr. Judge of the Criminal Court in and for Warren County, Tennessee, personally came Carolyn Young who, being first duly sworn, says that Pamela Joan Rogers Turner hereinafter referred to as the aforesaid, was on the 11th day of August, A.D. 2005, convicted of the offense of (4) Counts Sexual Battery by Authority Figure in the Criminal Court of WARREN County, which Court suspended the imposition of sentence and placed the aforesaid on Community Corrections for a term of (8) Eight Years, in accordance with the provisions of Title 40, Chapter 36 of the Tennessee Code Annotated. Deponent further states that the aforesaid has not properly conducted herself, but has violated the conditions of her Community Corrections in a material respect by violation of:

Rule # 2 *Make a full and truthful report to the Case officer in person and/or in writing as directed*
Count #1 Defendant on/about April 5, 2006 did give untruthful statement to house arrest monitor/Case Officer regarding internet access to computer in residence.

Rule #23 *be required to observe any special conditions imposed by the Court*
Sexual Offender Directive #3 and condition 23 will not have any contact in any form whether orally, written, visual text physical or other wise with the victim or the victim's immediate family while on probation... Sexual Offender Directive #5 will not have Internet access on your computer unless permission for Internet capability has be approved in writing by your Officer and consent to your Officer checking your computer and any software at any time for Internet capability or activity.

Count #1 Defendant on/about 3/30/06, 3/31/06, 4/1/06, 4/2/06, and 4/5/06 had E-Mail contact with victim's sister. Posted Comments on Defendant's Web Page; two Blog comments from victim's sister and two from victim's sister in friend's comments.

Count #2 Defendant on/about March 28, 2006 did sign on and created a Webpage and Blog on My Space.Com without written permission from case officer.

Count # 3 Defendant did sign on MySpace.com on 3/28/06, 3/30/06, 3/31/06, 4/1/06, 4/2/06, 4/3/06, 4/4/06, 4/5/06, 4/6/06, 4/7/06 and 4/9/06 without permission from case officer.

Count # 4 Defendant has sent out 126 email messages as of 4/10/06 on My Space.com and received 223 email messages as of 4/10/06 on My Space.com.

Count # 5 Defendant on/about 4/5/06 did deny access to capability of computer from house arrest monitor/case officer.

Count #6 on 4/03/06 and 3/30/06 defendant posted two comments on victim's sister's friends comment webpage on Myspace.com.

Count #7 Defendant posted text material on her myspace.com webpage to the victim by use of her hero, and that she would wait three years to fall in love, this being in violation of sexual offender directive #5 and condition #23 and condition of her plea.
